We also research and understand worldwide regulations that affect our products such as REACH, RoHS and others. We operate under a global ISO 9000 certificate and are committed to quality leadership and continual improvement to our products and processes.

"The Safe Drinking Water and Toxic Enforcement Act of 1986", also known as Prop 65, was enacted in 1986. Prop 65 is a standalone, state based program that affects all commercial goods sold in the State of California.
